- a. 6. Lisa Zuhn presented the **Executive Director Report**, highlights were:
 - a. **Community Conversations** – next Tuesday we are discussing “Building Community” focused on adults working with youth. Tara Adams and Ali Harper will be presenting (currently 34 people registered)
 - b. **One Circle** – Spanish Elementary School Girls Circle started, has 5 girls and meets twice a week. Planning girls and boys high school groups starting March 17. Danielle Sutherland is stepping down as One Circle Coordinator, currently have a job advertisement out. It is a part time position, roughly 6 - 15 hours per week on average depending on time of year. Coordinator will also facilitate groups.
 - c. **JJAC/CYFD** has rolled out their new reporting database.
 - d. **Network for Good Jumpstart program** helps non-profits work on their fundraising abilities. It is a \$1,200, one year commitment. Looking into it to see if we are eligible.
