3. Carter Payne made a motion for the **Approval of Today's Agenda**. Elizabeth Allen seconded, no discussion, all in favor, motion carried.

4. Nicole Raddu Ferry moved for the **Approval of the February 2021 Meeting Minutes**, Amanda MacDonald seconded, no discussion, all in favor, motion carried.

5. **Approval of FY20 990 Tax Filing** - Sharon Hurley, member of the Finance Committee, presented the Annual 990. The Finance Committee recommended to the board for the approval of the 990 with two minor amendments. The email address needs to be corrected and one of the board

member's name was incorrect. Morrie Pongratz made a motion to approve the 990 as amended, Martin Hook seconded, no discussion, all in favor, motion carried.

6. **JJAC/CYFD Database Discussion** - Lisa Zuhn provided a quick overview of the funding structure between JJAC/CYFD, Los Alamos County, and JJAB. With the implementation of their new database, CYFD is now requiring full name, full address, and date of birth for youth. Reimbursement of funding will not be available if the information is not provided. The main concern is privacy of youth information, and not all families will feel comfortable providing consent to share that information. The information would also be available to Los Alamos County Social Service Department as they also have access to the database. It is possible to shift some funding for this fiscal year, however there could be funding issues in the future. Several members of the Executive Committee information regarding the privacy concerns. Board members discussed the issues and options to address the concerns. If Board members are interested in being involved, email Lisa to be added to the Ad Hoc Committee in conjunction with the Executive Committee.
7. **Revisions to Bylaws and Board Policies** - Updates and recommended changes were presented by Ad Hoc Review Committee. Morrie Pongratz made a motion to approve the revisions to the bylaws and Board policies, Nicole Raddu Ferry seconded, no discussion, vote taken by roll call, all in favor, motion carried.
8. **Election of Chair, Vice-Chair, and Treasurer Positions** – Jordan Redmond explained the standard election process.

No additional nominations were received during the meeting. Morrie Pongratz moved to close nominations after each nominee was allotted time to make comments if they chose to, Suzanne Lynne seconded, no discussions, all in favor, motion carried.

Roll call vote was taken to confirm the nominees into the positions, all in favor, approved unanimously.
